### **NOTES TO THE FINANCIAL STATEMENTS**

#### **A. PRESENTATION:**

SPIL de Mexico S.A. de C.V. is a Mexican Company with foreign investors incorporated on February 13, 2002 under the Mexican laws; since the company has not started any business operating activities during the Year ended December 31, 2015, no Income Statement has been prepared for the period ended on that date.

The Financial Statements have been prepared in accordance with Mexican Financial Reporting Standards (Mexican FRS) as issued by CINIF (Consejo Mexicano para la Investigación y Desarrollo de Normas de Información Financiera, A.C.), the Financial Statements are presented in Mexican pesos.

#### **B. SIGNIFICANT ACCOUNTING POLICIES:**

##### **I. Basis of Accounting**

These financial statements are prepared under historical cost convention on an accrual basis in accordance with the Financial Reporting Standards (Mexican FRS) as issued by CINIF.

##### **II. Pre Operative Expenses :**

The expenses incurred by the Company prior to starting Operations are accounted as Pre Operative Expenses.

#### **C. NOTES TO FINANCIAL STATEMENTS:**

##### **1. CAPITAL STOCK**

As at December 31, 2015, the Fixed Capital Stock represents an amount of \$50,000 Mexican Pesos (Previous Year \$50,000 Mexican Pesos) represented by 100 (Previous Year 100) Nominative and free Shares of \$500 Mexican Pesos (Previous Year \$500 Mexican Pesos) each fully paid-up.
