1. ****Product Packaging Photos:****

It is clearly stated above that product photographs are not available.

2. ****Packaging Details Including Batch Information:****

As mentioned earlier, product photographs are not available.

3. ****Prescription for the Purchased Product:****

The prescription is attached below in this PDF. Please check the document till the last page .

4. ****Date and Mode of Purchase:****

Refer to the PDF for the bill in this pdf only, which specifies that the purchase was made offline.

5. ****Invoice for the Product:****

The bill is included in this PDF itself .

Most importantly, I want to clarify that this situation does not involve spurious or counterfeit products; it is solely a matter of incorrect batch numbers.

These bills belong to employees of the Delhi Jal Board, who submit them for reimbursement. It has been noted that at times, medical stores may not have a specific brand in stock or inventory. In such cases, to facilitate reimbursement, they may issue a bill based on the prescription while providing a substitute to the patient and including an incorrect batch number.
