Report of Scrutinizer on the results of Voting by way of postal ballot through remote e-voting ("Postal Ballot") in connection with the resolutions detailed in the Notice dated February 20, 2025, for seeking approval of members of Sun Pharmaceutical Industries Limited ("the Company").

I, Chintan Jagdishgiri Goswami, partner of M/s. KJB & CO LLP, Practicing Company Secretaries, have been appointed as the Scrutinizer for the purpose of scrutinizing the votes cast on the resolutions detailed in the Notice of Postal Ballot dated February 20, 2025 ("Notice"), for seeking approval of members of the Company by way of ordinary resolutions by means of Postal ballot in accordance with the provisions of section 110 and other applicable provisions of the Companies Act, 2013 ("the Act") read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended and other applicable rules under the Act ("Rules") and pursuant to the General Circular 09/2024 dated September 19, 2024 read with other circulars issued by Ministry of Corporate Affairs ("MCA Circulars") and circular no. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 issued by Securities and Exchange Board of India on October 3, 2024 ("SEBI Circular"), the Company sent the Notice only in electronic form to those shareholders whose e-mail addresses are registered with the Company/Registrar and Transfer Agent ("RTA")/ Depositories. Accordingly, physical copy of the Notice along with postal ballot form and pre-paid business reply envelope were not required to be sent to the shareholders for this Notice.

- The Company has sent Notice in electronic form to those shareholders, whose names appeared in the Register of Members / Records of Depositories as on February 17, 2025 ("cut-off date") and the 'Newspaper Advertisement' pursuant to Rule 22(3) of the Companies (Management and Administration) Rules, 2014 was published on February 21, 2025.
- 2. The Company had entered into arrangement with Central Depository Services (India) Limited ("CDSL") for providing electronic voting facilities through remote e-voting ("e-voting") to all the members who were eligible to take part in the voting process.
- 3. Our responsibility as a scrutinizer was to ensure that the processes of voting by way of Postal Ballot conducted in a fair and transparent manner and to submit a scrutinizer's report on the voting to the Company Secretary of the Company who is authorised by the Chairman of the Company, based on the report generated from the electronic voting system provided by CDSL.

  - 4.4 Voting rights of Equity shareholders have been reckoned in proportion to their shares in the paid-up share capital of the Company as on Monday, February 17, 2025.
